- 7. Nominations and Voting
- 7.1 Akoras in good standing are allowed to nominate or second only one person for particular position.
- 7.2 Akoras may cast their votes electronically 24 hours before the AGM, i.e. by 1700 Hours GMT on Saturday, 21st November 2015 or in person or by proxy at the AGM.
- 7.3 Where there is a tie for any position after counting votes cast electronically and at the AGM, there will be a deciding second round of voting by the members in attendance at the AGM.
- 7.4 Where there are not enough candidates elected to fill positions on the Executive Committee, the President may co-opt members to serve. This provision does not apply to the position of Treasurer which shall always be subject to election.
