4.0	ADOPTION OF AGENDA

5.0	CONFIRMATION AND ACCEPTANCE OF PREVIOUS MEETING'S MINUTES

6.0	MATTERS ARISING FROM PREVIOUS MEETING'S MINUTES	
6.1	OAA - Tullow Science Block Project	
	Akora President reported that on 20 th March 2020, the new	
	OAA-Tullow Science Block was handed over to the School.	

Akora President also informed the meeting that four (4) pavilions had been constructed and named after the 1974, 1975, 1976 and 1989 year groups. This followed their very significant contributions of at least \$20,000 towards the Science Block Project. The year groups had promised to furnish the 4 pavilions with benches at a cost of GHS 7,200 each. It was noted that two (2) year groups had already fulfilled their promise. The OAA was waiting for the other two (2) other year groups to furnish and hand over the pavilions to the School.

Akora President also reported that the new Science block was not yet in use because students had had to go home following the COVID 19 outbreak.

The meeting also learned that the Executive Committee had received from the School a list of items that were needed for operation at the new Science Block. The School had also made plans for the SHS 3 students to use the Science Block for preparations towards their WASSCE. Afterwards the Science Block would be opened to those in Second and First years respectively.

Akora President informed the meeting that Akora Yaw Benneh-Amponsah of the 1991 Year Group had secured support from GEODRILL Ghana Limited towards the furnishing of the new Science Block. Akora President expressed his appreciation and hoped that by the next academic year, the OAA-Tullow Science block would be ready for use.

OAA Website Registration/Database

The meeting was informed that the OAA website was launched a year earlier. All Akoras were expected to use it to register online. A total number of 645 Akoras had registered at the time of the meeting. The steps to be taken for registering had been circulated among the year groups. Akoras were encouraged to register so that the database could be updated.

The Executive Secretary assured the meeting that data collected were treated with confidentiality.

6.3 **OAA Newsletter**

Akora Yaa Boateng explained to the meeting that a new Newsletter was being planned and would be in electronic format in order to reach more members.

7.0 PRESIDENT'S REPORT

Akora President reported that all OAA events for the year had been done virtually since the pandemic broke. These included the Annual General Meeting, the Memorial Service held for departed Akoras and the Festival of Nine Lessons and Carols. He added that the Secretariat staff had had to work from home, but had been able to organize activities successfully.

Website/Database

7.1

The President reported that there were 645 Akoras registered on the new database. He noted that even though many members often complained about ineffective communication from the OAA, he did not see much engagement with the new interactive website. He encouraged Akoras to use the social media handles on the website to share information with and about OAA.

7.2 The Case of Achimota School and the Rastafarian Boys

The meeting learned the School Board lost both cases in the Rastafarian boys' lawsuits. The judge had ruled in favour of the boys because they were seen as being prevented from exercising their right to education under the constitution and their right to practice their religion. The meeting was informed that the School Board was planning an appeal.

Achimota School Lands

7.3

The Supreme Court ruled in favour of the School Board in the case it brought against the Osu Mankralo. The Court ruled the School Board had capacity to make decisions on all lands belonging to Achimota School.

It was also noted that the President of Ghana had granted a request from the School Board for permission to be able to transfer land to third parties, if necessary. The School Board would set up a Trust to be responsible for managing Achimota School Lands.

The meeting learned that, in the process of setting up the Trust for managing Achimota School lands, the Minister of Education was trying to insert himself as the Trustor of Achimota School lands. Akora President pointed out that the colonial government had handed over the management of the land to the Governing Council of Achimota School, and not the Department of Education at the time, in order to make its management independent of government officials.

The meeting also noted that the Trust Deed prepared with the Ministry of Education had excluded the OAA from the management of the land, even though the idea behind the setting up of the Trust originated from the OAA. The meeting found this unacceptable.

7.4 OAA Secretariat

Akora President informed members that there was the need to upgrade facilities at the School's Club House as OAA offices. He indicated that there was an earlier plan to build a new structure that could be used as an Events Centre to to generate revenue for the OAA.

Legacy Projects

7.5

1971 and 1981 Year Groups

7.5.1 It was reported that the 1971 Year Group and the 1981 Year Group had celebrated their 50 and 40 years respectively after leaving Achimota School. As legacy project, the year groups provided the School with Solar Power. Akora Amarquaye Armar (1971) give a brief on the project. He informed the meeting that the year groups collaborated with Senior officials from ECG, Ministry of Energy and the Energy Commission. The 1971 Year Group had prepared the blueprint on how the solar system would be mounted. The 1981 Year Group was spearheading the fundraising initiative. They appealed for support and contribution from Akoras.

7.5.2 **1997 Year Group**

Their legacy project was to elevate the ICT infrastructure at the School, including providing fibre optic cabling on the school compound. Akora Kwame Nkrumah Botsio, President of the Group, informed the meeting that they had adopted an "e-learning project", which included the upgrading of ICT infrastructure to international standards. He introduced the group's General Secretary, Akora Ralph Nii Tettey Amlalo and Akora Stephen Kemetse, as their Legacy Committee Chairman.

Akora Stephen Kemetse briefed the meeting that their project would be in 3 stages:

Stage 1- Provide fibre optic cables around the compound and then subscribe to Google classroom on behalf of the School and then train teachers on how to use the platform. The laying of cables and connectivity would cover Aggrey Chapel, Administration Block, all the Old Science Labs, the OAA-Tullow Science Block, the new and old Assembly Halls, all the Houses, OAA secretariat and the Headmistress's house. The infrastructure would carry data, voice and video. The meeting learned that work had begun with the laying of 42 core cables from Clark House across the oval and then moved into one of the ICT labs to start installation of equipment that would power the entire infrastructure.

Stage 2- Subscription to the Google classroom which the school could not afford. They had requested a fee-waiver from Google. The feedback from Google had been that they sponsored schools with functioning websites. Google also requested for proof of accreditation. The School had written to GES requesting documentation support.

Stage 3- Training of teachers. Akora Dr. Mary Eshun,
Principal of GIS had earlier started pilot training for 5
teachers to become trainers for the project. The project
would expand this to 200 teachers. They were categorized

into those requiring basic skills, intermediate skills and advanced skills. The training was scheduled for July and August. The Group hoped that by the fourth quarter of the year they would have completed the fibre optic cable work and the subscription to Google classroom, as well as the training of the teachers. They planned to make the facility available for use before the first quarter of next year when they would be celebrating their 25th anniversary.

Akora President thanked the 1971, 1981 and 1997 Year Groups and invited comments from Akoras.

Akora Yaw Benneh-Amponsah, member of the Executive Committee, was of the view that the year groups should work together to appeal for funds and this could reduce the cost of the different projects. He also informed the 1997 Year Group that the OAA Executive Committee was planning to train teachers, not just in the use of Google classroom, but to improve on their performance and educational outcomes.

Akora Edmund Wiredu commented on the laying of pipes. His concern was to ensure that existing water pipelines would not be damaged. The Group responded that there would be no digging to lay cables.

7.5.3 Other Comments on President's Report

An Akora suggested that, with regard to the planned appeal in the case of the Rastafarian boys, the School should simply "let sleeping dogs lie" and rather keep an eye on the boys and other students. He believed that there were

enough structures at the School to ensure that nothing would disrupt the system.

Akora Kwame Boakye thought consistency and fairness must cut across, and for that reason the School needed to look at the situation of the Rastafarian boys very carefully.

On the ICT project, Akora Kwame Boakye said he was prepared to talk to the team because he had worked on a few fibre network projects. He also suggested that the ICT project should include the OAA database project into what they were going to do. In his opinion to achieve an ICT Centre of Excellence, there should be the capacity to communicate effectively; OAA must be a key component within the ICT Center of Excellence project.

8.0 BUSINESS OF THE DAY

Report, Presentation and Consideration of Achimota School Endowment Trust Fund Accounts 2020

Akora Ivan Addae-Mensah, Chairman of the ASET Fund presented the Trust report. He noted that NDK Financial Services had been made the Fund Manager with significant challenges. The meeting learned that the sole source of funding remained the GHS 500 yearly levy paid by year groups and that fundraising had been a big issue. The Chairman noted that the Auditors had reported that the accounts had been well managed. The inflow of funds in 2020 was slightly lower than in 2019. In 2019 inflows went up partly because of the new launch of the fund. In 2020, the Administrator managed to get more Year Groups to contribute towards the funds. Salaries and expenditure went up in 2020.

The Fund also made a contribution of \$5,000.00 towards the new Science Block Project, and that made total investment in 2020 less than 2019.

The Treasurer, Akora Antoinette Kwofie formally presented the ASET Fund accounts as at 31st December 2020. (copy on file).

Akora Bossman-Laryea commented on behalf of the Auditors BLA & Associates, Chartered Accountants. In their opinion, proper books of accounts had been kept, the financial statement gave a true and fair view of the state of affairs of the Fund as at 31st December, 2020; and the income and expenditure statement and cash flow statement for the year then ended complied with international Financial Reporting Standards and the Ghana Companies Act 2019. (Acts 992)

Akora Patrick Mensah of the 1964 Year Group wanted to know whether there was any reason to pursue fund raising when Achimota School had all that land that could be commercially developed. He suggested that with all the land that Achimota School had, it could leverage the commercial side of it to raise revenue for the endowment fund. He wanted to know if there were any legal restrictions on such a venture. Akora President commented that these were very important observations, and that was the goal of OAA. He noted that the creation of a Land Trust and the development of a trust deed were intended for that purpose.

Akora Harold Richardson moved for the adoption of the report of the Endowment Trust Fund and the Financial Statement and was seconded by Akora Harold Esseku.

Akora President made suggestions to enhance the fundraising capacity of the ASET Fund. He proposed that Akora Yaw Benneh-Amponsah and the Treasurer, Akora Antoinette Kwofie, be co-opted on to the Board of Trustees. The Executive Committee had confidence that the Board of Trustees would help in making the right investment decisions and advise. Akora President mentioned they had the full support of OAA to help meet the target. This was accepted by the meeting.

8.2 Presentation and consideration of OAA Audited Accounts for 2020

The Treasurer, Akora Antoinette Kwofie presented the accounts for the Old Achimotan Association as at 31st December 2020. (copy on file).

On behalf of the Auditors BLA & Associates, Chartered Accountants, Akora Bossman Laryea presented the opinion of the Auditors to the meeting. He stated that proper books of accounts had been kept, and the financial statements which were in agreement, gave a true and fair view of the state of affairs of the Association as at 31st December, 2020 and of the income and expenditure statement and cash flow statement for the year then ended, and complied with International Financial Reporting Standards and the Ghana Companies Act, 2019, (Acts 992).

An Akora wanted to know how the initial \$1 million target was arrived and it was explained that it was based on what it took to do the Science Block Project which cost almost \$1 million. The Executive Committee used it as an indication of the strength of Akoras.

Akora Yaw Benneh-Amponsah pointed out that donations of a thousand dollars would lead to one's name being permanently engraved on a wall somewhere near the Administration Block. Akoras who contributed less than a thousand dollars would also be recognized as appropriate.

There was a question about whether there were any policies to assist Akoras in getting their children into the School. It was answered that there was a policy where some protocol admission was negotiated; many Akoras have had their children, nephews and nieces etc. come to the School through the protocol admissions given to OAA. Before one can take advantage of it, however, he/she must pay dues and other obligations in full.

Akora Philip Aboagye proposed that the Endowment Fund must be invested with government funds and not private funds. It was answered that the suggestion would be considered by the Fund Managers.

Two members of the 1997 Year Group Executive Committee; Akoras Ralph Tettey-Amlalo and Kwame Nkrumah Botsio pledged \$1,000.00 each.

Akora Kwaku Sakyi Addo suggested that younger Akora Year Groups could come together to contribute in bulk so that they could be recognized as a group. Akora President agreed with Akora Sakyi Addo.

Akora Isaac Quist asked whether Achimota Golf Club was going to contribute towards the endowment fund. Akora President responded that the School would appeal to them.

Akora D. V. Osei suggested that OAA could look for options and encourage Akoras to choose such as;

- 1. monthly installment of \$100 monthly for 12 months,
- 2. quarterly payments of \$250,
- 3. one-time payment of \$1,000

The meeting accepted the proposal and Akora President concluded that the Finance Sub-Committee of the OAA Executive Committee will look at the suggestions that came up, and see how best to put them into practice.

Akora Freda McEyeson pledged \$5,000,

Akora Kwabena Kwakye Asomaning pledged \$5,000 on behalf of the Boateng family,

Akora Kwame Boakye and wife pledged \$5,000,

Akora Antoinette Kwofie pledged \$1,000,

Akora President and wife pledged \$5,000,

Akora Abankwah Yeboah, \$1,000 and

Akora Sarah-Lynn Mansaray pledged \$1,000.

9.0 Achimota School Centenary Celebrations

Akora President informed the meeting that a few Akoras had approached him on what legacy project OAA would like to undertake for a centenary project since it was only six years away. He said one of the suggestions that came up at an Executive Committee meeting was to construct an Auditorium to replace the Science Lecture Theatre.

Akora President wanted to know whether there were any other developments Akoras would like the OAA to consider for the School as it turned 100 years.

Akora Harold Esseku said the Projects Committee was compiling a list of projects, including the rehabilitation of the water supply system at the School. Ghana Water Company Limited was getting an estimate to change the whole system and to cut the water supply system of the School from other communities. The Committee was putting together all the various projects, including ones that OAA could implement, those that Year Groups could undertake, and the ones that could get support from the government such as what 1971 and 1981 were doing.

Akora Esseku informed the meeting that Ghana Water Company Limited had presented 3 estimates for a water project and his Committee was looking at them in different phases. They would get the full list out and make it available for Year Groups to choose from.

10.0 Any other Business

10.1 National Science and Maths Quiz

Akora Kwabena Kwakye Asomaning spoke about the upcoming National Science and Maths Quiz and suggested empowering teachers to push the students further.

Akora Sarah-Lynn Mansaray told the meeting that she had three issues. The first was the she was a member of an online group that had been looking at the possibility of renaming buildings and structures at Achimota School. They sent a proposal to the Board in November 2019 before the COVID pandemic struck, but had not had any response. She was wondering whether OAA could use its weight to push for the adoption of proposal. Specifically, they wanted the Art School to be named after Akora Kofi Antubam.

The second issue she raised was that she had seen Akoras referring to a "National Executive Committee" online, but there was no such thing. It was simply "Executive Committee". The third issue was an appeal not to use the jubilee cloth as table cloth.

Akora Kwame Boakye suggested that, as a way of helping the School, older Akoras like him could consider willing portions of their estate to Achimota School, even though it was not a common practice in Ghana. He thought it was something worth considering.

Akora Harold Richardson moved for the closing of the meeting and this was seconded by Akora Edmund Wiredu.
